

# **Privacy Policy**

This privacy policy applies in relation to the website located at https://mojoict.co.za/ (the "website"). The website is owned by Mojo ICT (Pty) Ltd. This privacy policy is binding on everyone who chooses to access the website without qualification or exception. By using this website, the person accessing the website (the "User") agrees to be bound by this policy, and acknowledges that the User has read and understood them. If the User does not agree to any of the Terms, the User should not enter, view, or make use of the website.

# **The Information We Collect**

Mojo ICT uses your personal information in accordance with the Mojo ICT's Terms and Conditions that we have entered into with the User for the access to and use of Mojo ICT's services. Mojo ICT collect your Personal Information directly from Users when the User enters the Website, submits the User's details on the Website, sign up to use Mojo ICT's services and/or when we on-board you to open an account for you and/or when you make use of our web forms (to provide to us your name and contact details). ## Security

Mojo ICT will store all the personal information you provide on our secure servers and will take reasonable technical and organizational precautions to prevent the loss, misuse, or alteration of your personal information.

If you are issued with a password, you are responsible for keeping the password you use for accessing our website confidential; we will not ask you for your password.

## **Accessing Information**

Individuals may review their personal information contained in Mojo ICT files by contacting Mojo ICT If an individual believes that any of their personal information is inaccurate, we will make appropriate corrections.

#### Cookies

Cookies are used by Mojo ICT for the convenience of our users. Cookies automatically authenticate the User. A user can access the Mojo ICT website with the cookie feature turned off; however, in doing so they may find themselves challenged for username and password information on multiple occasions. Mojo ICT also uses cookies to track User's visits and uses that information to improve the User's experience.
